#### Department of Health—Food Division

Responsibility: Outside food preparation is covered by both state law and local ordinance. If merely serving food outside, there are no restrictions. Outside cooking requires appropriate covering from insects, elements, animals, etc. Must have handwashing, overhead cover, a means of dishwashing, refrigeration and hot-holding. Seating requirements during the COVID-19 will be reviewed for social distancing. Every situation is different and may necessitate different requirements. It is best to contact the Department of Health Food Division at the beginning of your planning process.

#### **Allen County Building Department:**

#### City Utilities Development Services

Responsibility: Making changes to plumbing systems (water and/or sewer). Construction of new patios using paving materials (asphalt, brick, concrete, stone) may require a connection to the existing drainage system to ensure proper drainage, or a new connection directly to a city storm sewer if not able to connect to their existing drainage system. A direct connection to a city storm drain could be expensive, so alternatives should be sought to avoid this requirement on a case-by-case basis.
